The Commission, staff, and members thank Phil for his professional management of Basketball SA and his dedication to the sport industry. Phil will continue to be acknowledged for his instrumental role in securing funding for the State Basketball Centre, a major project which Phil has continued to contribute to in a volunteer capacity since vacating the CEO position.

With new leadership however, comes new vision. Tim has stepped into the CEO role seamlessly, having a depth of basketball expertise and experience across a multitude of roles and functions. We look forward to the journey and thank Tim for his efforts to date.

The strategic plan has continued to guide the work of the Commission and Basketball SA with a major focus on ensuring the State Basketball Centre delivers maximum impact to the basketball community.

STRATEGIC ACHIEVEMENTS

Sustainable Financial Growth

Basketball SA has been supported by government with funding and a training and development package to review the current governance structure of basketball in South Australia. Basketball SA will learn from leaders in sport and engage in a genuine consultation process with our members to modernise the structure of basketball and ensure basketball is in a favourable position for future funding and infrastructure opportunities. Succession planning for the Finance and Audit Committee saw a new Chair commence in 2022 with the previous Chair remaining as a mentor and committee member for a smooth transition. The Female Participation Levy continued to be applied in 2022 with a fee for service model introduced to improve member benefits and Adelaide Lightning engagement.

Member Engagement

The Commission held two member workshops over the year to provide an opportunity for all members to exchange information with the Commission, provide feedback, better understand the basketball landscape, and influence strategic decision making. A process for President Induction was commenced in 2022 with Basketball Adelaide Presidents. The induction process was a joint initiative of Basketball SA and Basketball Adelaide and has been very well received by new and existing Presidents alike. The induction process has provided new Presidents with critical information about their role to aid the improvement of club governance frameworks and succession planning.

Strong Frameworks and Services

Basketball SA signed a three year contract with World Sport Action to introduce a new CRM for the sport. Basketball Connect will replace Gameday and provide a robust records and competition management system to facilitate the collection of accurate data that can be used in sport advocacy. Basketball Connect is promised to be an easier interface for members, can be tailored for our specific needs, and will improve the efficiency of competition management. The Behaviour Management Framework has been in place for the 12 months of 2022. While spectator behaviour continues to be a concern for the sport, the understanding across the community has seen improvement following a comprehensive campaign aimed at changing the culture. Both the Behaviour Management Framework and the Female Participation Strategy have received positive national and industry attention for Basketball SA.

Facilities and Infrastructure

Basketball SA has worked tirelessly to realise the commencement of construction of the State Basketball Centre (SBC), which has broken ground in 2022. A great deal of negotiation, planning and design to obtain the best possible result for basketball will result in a state of the art facility, opening in 2023 at the Wayville Showgrounds. The SBC will become the home for basketball in South Australia, boasting 4 new courts, a show court, high performance facilities, professional changerooms, FIBA standards, changing places, a sensory room, history wall, and office spaces.

With a project budget of around \$17 million, the SBC is the biggest project for Basketball SA since the Adelaide 36ers Arena was opened in 1991 (then known as the Powerhouse Stadium). The SBC project is a collaboration between the State government, Basketball SA, and the Royal Agricultural and Horticultural Society. The Commission is committed to ensuring the investment of funds from Basketball SA will not impact the sustainability of the organisation nor restrict future capital works or infrastructure investment.

Basketball SA secured leases to access new facilities for basketball at Reynella East and Mitchell Park, and supported SA Church to obtain court use at Scotch College. The 3x3 training court at Port Adelaide is near completion, and funding was secured to install air conditioning at Springbank Stadium. The Commission continue to explore future stadium management modelling options that will provide the best outcomes for the sport as a whole.

Provide more opportunities for Play and Grow

The activities of the Female Participation Strategy reached 3950 primary school children across the state, exceeding the KPI established for 2022. The strategy resulted in an increase in female junior district players, female referees, female leadership, and female inclusive participation. Basketball Australia funding for Wheelchair Basketball contributed to increased development programs resulting in the Wheelchair Basketball Association sending the first home grown team to compete at the Kevin Coombs Cup. Overall, there was an increase in referee and coach accreditation courses including the introduction of an online Community Coach Course to facilitate more engagement and remote access.



Basketball SA's Behaviour Management Framework, sets the standard for good behaviour both on and off the court. An extensive promotional and education campaign was undertaken that included development of animations for relatable messaging.

Other basketball state and territory associations around Australia have acknowledged the ground breaking work being done in this space, and have followed a consistent path. Basketball SA will continue to review and improve the Behaviour Management Framework, to ensure that all referees at all levels are provided with safe working conditions and an environment to thrive.



The behaviour of spectators, and coaches continues to be the driving issue in less than acceptable referee retention. As the governing body, we are exploring a multitude of strategies to educate and improve the behaviour state wide.



FINANCIAL REPORT

The period January 2022 to December 2022 saw a return to "business as usual" over the course of the year for Basketball, after several years of disruption due to COVID-19. The opening of the state borders in the early part of the year did result in impacts in the first few months as the regulations around close contacts and isolation were integrated within the competition.

Construction on the State Basketball Centre (SBC) began, with significant progress made over the course of the year. A wet winter with heavy rain did cause delays to the initial site works and as a result the expected finish date, along with some minor cost increases overall.

New leases for court use were signed at Mitchell Park Sports & Community Centre (2 years) and Reynella East College (3 Years), as well as the extension of the lease at Springbank College (20 years). The impact due to the statutory accounting requirements for the treatment of leases causes a large unfavourable impact vs the actual cash cost at the beginning of a lease. It is important to note this is a non-cash impact only, which will cause an impact to the statutory results but not the overall cash earnings. An overall increase in participation and registered players saw an increase in revenue growth over the course of the year. Competitions continue to be an area of high importance within the budget, with increasing pressure on costs impacting the price for families to participate. Basketball SA remains committed to keeping the fees for all participants as low as possible, however high inflation and the higher costs to run competitions as a result require careful monitoring.

The net result for 2022 year was a statutory deficit of \$26,335. When adjusting for non-cash impacts due to depreciation, statutory reporting lease treatment and capital expenditure, the net result was a cash earnings surplus of \$74,316.

Basketball SA will continue working with local councils, state government and federal government to support the increase in facilities and infrastructure required for the sport, whilst also focusing and investing in the need to increase the recruitment, retention and availability of officials.

Basketball SA would like to thank all sponsors and partners for their assistance throughout the year. Basketball SA would particularly like to thank the South Australian Office of Recreation, Sport and Racing and Basketball Australia. The assistance of our partners is essential in allowing the continued operation and improvement of the delivery of programs.
