- (c) must not be on the management committee (or similar body) of or employed by any affiliate of Basketball Adelaide, SA Church or SA Country specifically including any District Club, Church Club or Country Association or the Adelaide Lightning Basketball Club or the Adelaide 36ers Basketball Club.
- (d) must not receive an honorarium payment exceeding a minimum threshold (to be determined annually by the Commission in its instruction to the Nominations Committee) from any affiliate of Basketball Adelaide, SA Church or SA Country;
- (e) must not have a commercial, financial or legal prejudicial interest in the operations of Basketball SA, declared or perceived.
- (f) must not have held a position detailed in (b) (c) or (d) above anytime within the last 3 years, nor have held a position for such a period that their independence has been compromised.
